Early Years Foundation Stage (EYFS) Policy

The Early Years Foundation Stage (EYFS) applies to children from birth to the end of the Reception year. At the Potton Federation, children join the Reception class in the year that they turn five. In partnership with parents and carers we enable the children to begin the process of becoming active learners for life.

We endeavour to ensure that children “learn and develop well and are kept healthy and safe.” We aim to support children in their teaching and learning to ensure children’s ‘school readiness’ and to give children the ‘broad range of skills that provide the right foundation for good future progress through school and in life.”

(Statutory Framework for the EYFS 2012)

The EYFS is based upon four principles:

- A unique child – developing resilient, capable, confident and self-assured individuals.
- Positive relationships – supporting the children in becoming strong and independent.
- Enabling environments – where opportunities and experiences respond to the individual needs of the child by developing a strong partnership between practitioners, parents/carers and the child.
- Learning and developing – An acknowledgement that children learn in different ways and at different rates.

A Unique Child

We recognise that every child is a competent learner who can be resilient, capable, confident and self-assured. We recognise that children develop in individual ways, at varying rates. Children’s attitudes and dispositions to learning are influenced by feedback from others; we use praise and encouragement, as well as celebration/sharing assemblies and rewards, to encourage children to develop a positive attitude to learning.

Inclusion/Special Educational Needs (SEN)

All children and their families are valued at the Potton Federation. Children are treated as individuals and have equal access to all provisions available. All children are encouraged to achieve their personal best and planning is adapted to meet the needs of all groups and abilities. Assessments take into account contributions from a range of perspectives to ensure that any child with potential special educational needs is identified at the earliest possible opportunity. Early identification of special needs is crucial to enable staff to support the development of each child. Concerns are always discussed with parents/carers at an early stage.

We meet the needs of all our children through:

- Planning opportunities that build upon and extend children’s knowledge, experience and interests, and develop their self-esteem and confidence;
- Using a wide range of teaching strategies based on children’s learning needs;
- Providing a wide range of opportunities to motivate and support children and to help them to learn effectively;
- Providing a safe and supportive learning environment in which the contribution of all children is valued;
- Using resources which reflect diversity and are free from discrimination and stereotyping;
- Planning challenging activities for children whose ability and understanding are in advance of their language and communication skills;
- Monitoring children’s progress and taking action to provide support as necessary.

Welfare

It is important to us that all children in our school are ‘safe’. We aim to educate children on boundaries, rules and limits and to help them understand why they exist. We provide children with choices to help them develop this important life skill. Children should be allowed to take risks, but need to be taught how to recognise and avoid hazards. We aim to protect the physical and psychological well-being of all our children.

“Children learn best when they are healthy, safe and secure, when their individual needs are met and when they have positive relationships with the adults caring for them.”

(Statutory framework for the EYFS 2014)

At the Potton Federation we understand that we are legally required to comply with certain welfare requirements as stated in the Statutory Framework for Early Years Foundation Stage 2012. We understand that we are required to:

- promote the welfare and safeguarding of children
- promote good health, preventing the spread of infection and taking appropriate action when children are ill
- manage behaviour effectively in a manner appropriate for the children’s stage of development and individual needs
- ensure all adults who look after the children or who have unsupervised access to them are suitable to do so
- ensure that the premises, furniture and equipment is safe and suitable for purpose
- ensure that every child receives enjoyable and challenging learning and development experiences tailored to meet their needs
- maintain records, policies and procedures required for safe efficient management of the setting and to meet the needs of the children

Positive Relationships

At the Potton Federation we recognise that children learn to be strong and independent from secure relationships. We aim to develop caring, respectful, professional relationships with the children and their families.

Parents as Partners

We recognise that parents are children's first and most enduring educators and we value the contribution they make. We recognise the role that parents have played, and their future role, in educating the children. We do this through:

- An information evening for parents in May / June where they receive the Reception Information booklet and the School Prospectus which highlights school start and finish times, uniform and informs the parents of the Federations vision and aims
 - An opportunity to talk to the Reception team and representatives from other areas of school life e.g. PTA, Governors and the the Nest
 - Asking parents to complete an admissions form, a medical form and write a synopsis about their child including their likes, dislikes and any concerns they may have
 - Asking parents to sign permission slips for visits out of school, photographs of their child for assessment purposes and using the internet at school
 - Encouraging parents to talk to their child's teacher if there are concerns
 - Inviting parents to attend informal meetings providing information about other areas of the curriculum e.g. Early Reading, Maths and Phonics
 - Talking to parents about their child before their child starts in our school, usually through Home Visits
 - Ensuring children have the opportunity to spend time with their teacher before starting school during transfer sessions
 - There is a formal meeting for parents twice a year at which the teacher and the parent discuss the child's progress in private with the teacher. Parents receive a report on their child's attainment and progress at the end of each school year
 - Organising a range of activities throughout the year that encourage collaboration between child, school and parents / carers: Open afternoons, Class assemblies, Sports Day etc
 - Inviting parents / carers to make comments through 'Good News Slips' relating to the children's achievements
 - Written contact through reading diaries as well as the acknowledgement that parents can ring school to contact staff or the Foundation Stage Leader
 - The children have the opportunity to spend time in their new setting before starting school during 'preschool visit sessions' held throughout the year and transfer morning/afternoon
 - Offering parents / carers regular opportunities to talk about their child's progress in our reception class and allowing free access to the children's 'Learning Journey' booklets and classroom displays

- Parents / carers are made aware of the curriculum and ongoing activities through the weekly plans being posted on the parents' notice board by the Foundation Stage gate,

half termly newsletter or the school website. Any other relevant messages/information, curriculum guidance booklets relating to the half-termly topics are sent out separately.

All staff involved with the EYFS aim to develop good relationships with all children, interacting positively with them and taking time to listen to them. At our Federation, the EYFS teachers act as 'Key Person' to all children in EYFS, supported by the other practitioners. We have good links with the Potton Preschools. Regular visits are undertaken by the EYFS teachers and practitioners. Staff and children from the preschools are regularly invited to school events (Open Days, Assemblies, and Christmas Productions etc).

Enabling Environments

We aim to create an attractive and stimulating learning environment where children feel confident and secure and challenged. The children have daily access to an indoor and outdoor environment that is set up in discrete areas of learning with planned continuous provision. Effective learning builds and extends upon prior learning and following children's interest. Effective planning is informed by observations of the children to ensure that we build on children's previous knowledge. We provide the children with a broad range of practical experiences and guide children in developing their knowledge and understanding. These observations are noted in the children's individual record using the 2 Simple – 2 Build a Profile Play software programme and Classroom Monitor assessment database.

Play based learning is paramount and children direct their own learning from carefully planned opportunities provided by staff. Staff will enhance play and extend as needed to further individual learning.

Learning and Development

Teachers and Early Years Practitioners provide the curriculum in the reception classes of up to a combined class size of 60 children.

There are seven areas of learning and development of which three are "prime areas," and four "specific areas."

The prime areas are:

- Communication and language
- Physical development
- Personal, social and emotional development.

The specific areas are:

- Literacy
- Mathematics
- Understanding of the world
- Expressive arts and design

Through careful assessments and observations, including information provided by parents and other settings, children's development levels are assessed. The balance will shift towards a more equal focus on all areas of learning as children grow in confidence and ability within the three prime areas. However, if a child's progress in any prime area gives cause for concern, staff will discuss this with the child's parents and/or carers and agree how to support the child.

At the Potton Federation: "Each area of learning and development is implemented through planned, purposeful play and through a mix of adult-led and child-initiated activity.

Play is used as an essential part of children's development, building their confidence as they learn to explore, to think about problems, and relate to others. Children learn by leading their own play, and by taking part in play which is guided by adults. There is an on-going judgment to be made by practitioners about the balance between activities led by children, and activities led or guided by adults. Practitioners must respond to each child's emerging needs and interests, guiding their development through warm, positive interaction. As children grow older, and as their development allows, it is expected that the balance will gradually shift towards more activities led by adults, to help children prepare for more formal learning, ready for Year 1."

(Statutory Framework for EYFS 2014)

Planning and guided children's activities will reflect on the different ways that children learn and reflect these in their practice. At the Potton federation we support children in using the three characteristics of effective teaching and learning. These are;

- **Playing and exploring** - children investigate and experience things, and 'have a go'
- **Active learning** - children concentrate and keep on trying if they encounter difficulties, and enjoy achievements
- **Creating and thinking critically** - children have and develop their own ideas, make links between ideas, and develop strategies for doing things.

At the Potton Federation we follow the RE Agreed Syllabus for Bedford Borough, Central Bedfordshire and Luton 2012-17: Identities, Meanings and Values. We teach PSHE and citizenships according to the objectives set out in the Early Years Goals (ELGs). Our teaching in PSHE matches the aim of developing a child's personal, emotional and social development

as set out in ELGs. We also support citizenship education in the Reception classes, when we teach 'how to develop a child's knowledge and understanding the world'.

Equal Opportunities

All members of the Federation are treated as individuals. We aim to meet the needs of all, taking account of gender, ability, ethnicity, culture, religion, language, special educational needs, disability, and social circumstances. All staff are aware of the need for the curriculum to reflect 'the fundamental British values of democracy, rule of law, individual liberty, mutual respect and tolerance for those with different faiths and beliefs, these are implicitly embedded in 2014 Early Years Foundation Stage Curriculum.

Health and Safety

At the Potton Federation there are clear procedures for assessing risk which includes procedures for keeping children safe during outings and for any aspects of the environment or provision that may require a further risk assessment.

In line with the EYFS statutory framework 2014, at the Potton federation we undertake;

- A whole school medicines policy ensuring that there are systems in place to ensure that medicines and the systems for obtaining information about a child's needs for medication are kept up to date. Medicines will not be administered unless they have been prescribed by a doctor. Training is provided for staff where the administration of medicine requires medical or technical knowledge. Medicines (both prescription and non-prescription) are only administered to a child where written permission for that particular medicine has been obtained from the child's parent and/or carer." At Potton Lower a written record is kept each time a medicine is administered to a child and informs the child's parents and/or carers on the same day."

- Fresh drinking water is available at all times.
- Children's' dietary needs are recorded and acted upon when required.
- Milk and fruit are available during the morning session.
- A first aider is accessible at all times and a record of accidents and injuries is kept.
- A fire and emergency evacuation procedure and policy
- A safeguarding policy stating how mobile phones and cameras are to be used and stored securely whilst children are in the setting. Cameras that are used in school must not be used for staff own personal use.

The Learning Environment

The EYFS classroom is organised to allow children to explore and learn securely and safely. There are areas where the children can be active or take things more quietly. The classroom covers all learning areas, where children are able to find and located equipment and resources independently. The EYFS class has its own large enclosed outdoor area. This has a positive effect on the children's development. Being outdoors offers opportunities for doing things in different ways and on different scales than when indoors. It offers the children the ability to explore, use their senses and be physically active and exuberant. We plan activities and resources for the children to access outdoors that help the children to develop in all areas of learning.

Transition from Pre-school /Feeder settings

- During the summer term prior to a child's entry into the Reception year, the following procedures have been put into place to ensure successful transition
- Parents are invited to a meeting to ensure they know about school procedures and allocation of classes and any concerns they may want to express
- During the summer term parents are encouraged to help their children put a 'treasure box' together. It is used during the staggered start to support transition and to inform planning and to provide assessment
- The children are invited to a number of visits throughout the year to their reception class. The first visits are with their pre-school settings, allowing the children to feel secure in the new environment. In the summer term the children visit at least once without the support of the pre-school practitioners or parents.
- Members of staff from the Potton Federation make links to feeder settings. The number of meetings/visits will depend on the child's needs and how much information gathering is required in order to support the child's transition.

During the summer term before children join Potton Lower School, or alternatively the first week of the autumn term, home visits are carried out. These visits allow parents and children the opportunity to chat with practitioners in a less formal way in the comfort of their own home (the dates for these visits are subject to change each year, due to the variation in term dates).

From Reception Class to Key Stage 1

During the final term in Reception, the EYFS Profile is completed for each child. The Profile provides parents and carers, staff and teachers with a well-rounded picture of a child's knowledge, understanding and abilities, their progress against expected levels, and their readiness for Year 1.

The Profile includes on-going observation, all relevant records held by the setting, discussions with parents and carers, and any other adults whom the teacher, parent or carer judges can offer a useful contribution.

Each child's level of development is assessed against the early learning goals. The profile indicates whether children are meeting expected levels of development, or if they are exceeding expected levels, or not yet reaching expected levels ('emerging').

Year 1 teachers are given a copy of the Profile report together with a short commentary on each child's skills and abilities in relation to the three key characteristics of effective learning. This informs the dialogue between Reception and Year 1 teachers about each child's stage of development and learning needs and assists with the planning of activities in Year 1.
